### University of Ljubljana, Faculty of Law

#### 1. LONDON

Our trip started in London, where we had two free days, during which we explored the city, did some sightseeing and shopping and admired the "November" Christmas lights.



On our last day in London, we had the opportunity to visit the Supreme Court, meet with Lord Lloyd Jones, visit the Honourable Society of the Inner Temple and visit the seminar organised by the Honourable Society of the Inner Temple on the topic of Ukraine War: Peace-making Ahead - Traditional Methods of Accountability or New Solutions?

#### 2. VISIT OF THE SUPREME COURT



We had a guided tour of the Supreme Court, during which we even got an opportunity to try and sit in Lord and Lady Justices' chairs. We were surprised that inside the building everything is decorated with a flower symbol. We were told that the symbol is a Supreme Court emblem, which represents all three jurisdictions of the UK - the rose interwoven with the leek leaves for England and Wales, the thistle for Scotland and the flax plant for Northern Ireland. We also got an opportunity to visit the Supreme Court's library, which visitors are usually not allowed to see.

We had an honour to have a meeting with Lord Lloyd Jones. We were amazed by his kindness and are very thankful for his time and advice he gave us regarding our careers. It was great to hear first hand how the judge's work looks like and what are the hardest cases decisions to take.
